Applications are invited from qualified candidates who wish to be considered for appointment as Handy Worker at the Le Morne Heritage Trust Fund.

II. AGE LIMIT

Candidates, unless already in the Public Sector, should not have reached their 48th birthday by the closing date for the submission of applications.

III. QUALIFICATIONS:

The Certificate of Primary Education

- 1. In the absence of candidates possessing the Certificate of Primary Education, consideration will be given to candidates who show proof of being literate.
- 2. The Le Morne Heritage Trust Fund reserves the right:
 - (i) to convene **only** the best qualified candidates for interview; and

IV. DUTIES AND SALARY:

- 1. To be responsible to the Site Manager for the performance of the following duties:
 - (i) opening and closing of the office and gate of the International Slave Route Monument Site;
 - (ii) cleaning and maintaining the physical environment of the office and the Le Morne Cultural Landscape including the International Slave Route Monument Site and the Trou Chenilles Open Air Museum at a good standard;
 - (iii) handling and operating equipment such as trimmer, blower, chainsaw, pressure washer and brush cutter and tools such as land mower, hoe, hose, basket, etc. and maintaining them in good standard;

- (iv) weeding, digging trenches, cleaning, trimming hedges, planting grass, mowing, production and planting of seedlings, planting, and maintenance of plants;
- (v) maintaining tracks and trails;
- (vi) disposal of waste materials;
- (vii) performing simple masonry works and attending to minor painting and electrical works, as and when required; and
- (viii) attending to visitors.
- 2. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Handy Worker in the roles ascribed to him.
